They are still chasing ComEd bills, we are paying them, but it is not reflected on the bills we are getting because the check is crossing in the mail with the new bill. HC got a new phone, and the Verizon Bill came today. Working with the county on MFT funds to blacktop the north end of Cherry Hill. A resident called HC Walsh and wanted speed bumps on Noel Rd. HC Walsh wanted the resident to get consensus amongst all Noel Rd residents. Discussed Solar Farm and permits to move materials on Millsdale Rd.
