Road Report: Homewood Disposal was hired for Street Sweeping. The focus is on the streets with curbs because the leaves get stuck and don't go anywhere. They will be hired again in late fall after the leaves fall in the street. HC Walsh reached out to Austin Tyler because their bill came in considerably lower than their bid so he asked them to come back and blacktop a 1/4 mile stretch of Coldwater Rd and we still came in under budget for the larger blacktop project. A new truck is on schedule to be built next week and have it by October to be sent to get the snowplow put on. The 6 wheeler that was ordered will be about two years. He worked with McCann to replace the end loader we currently have.

Town Report: Supervisor Robbins spoke with Brandon from the village about Thanksgiving and Christmas baskets and he will reach out to the school social worker to get names of families that might benefit. The Town Hall looks great.

Trustee Comments: Trustee N. Fanning asked about the mowing at the cemeteries. The discussion was had that we haven't heard anything from Rayna Brophy about the cemeteries.
