Road Report: HC Walsh gave an update to a concerned citizen who came two months ago about a house that had trucks parked in the yard and HC Walsh spoke to Will County Land Use about this house and an additional house on Breen Rd and since he has both lots have been cleaned up. HC Walsh did another street sweeping this week, they pay Homewood Disposal. His office is ready to go if it does snow or ice up. He is also working with ComEd to figure out why we haven’t gotten a bill for streetlights.
