Austin Tyler received the bid. He would like a completion date of August 29<sup>th</sup> he would like it done before Labor Day. He attended a meeting at the County Board with the City of Joliet, they are trying to find solutions to the truck traffic, specifically at Sharp Rd. City of Joliet is struggling to keep trucks on designated routes too. Speed bumps were installed on Raymond Drive in Gladdale subdivision.

**Town Report:** Supervisor Robbins let the Board know National Night Out is August 5<sup>th</sup>. The Township will have their truck out. HC Walsh and Supervisor Robbins got emails about installing an anaerobic digestor on Hoff Rd which will take food scraps and pump it out into a pipeline as methane. This company has an application with the county and they are willing to come and sit with the board and the planning and zoning commission if we would like.
